4) Provide the Email Address for Notifications

By registering for SIDES E-Response, you agree to the following:

- An email notification will be sent to the email address you provide at the time of registration when:
 - employee separation information is required
 - employee earnings verification information is required, or
 - an unemployment insurance eligibility determination is issued.
- It is your responsibility to maintain a valid email address. The email address provided can be updated any time by logging into the UIConnect Benefit Center.
- Separation and earnings verification information will be submitted through the SIDES E-Response website, <http://uisides.org>, using the link provided in the email notifications.
- Eligibility determinations will be provided through the SIDES E-Response website, <http://uisides.org>.
- In accordance with 221 NAC 3 (004)(A)(3), you have 10 calendar days to provide employee separation information. Failure to respond on time may result in charging to your employer experience account and your appeal rights being denied.
- Request to Employer for Separation information (paper form UI-350) and eligibility determinations (paper form UI-410) will no longer be mailed.
- Initial requests for Unemployment Insurance Benefit Payment Audit information (paper form) will no longer be mailed.

- Before logging into SIDES E-Response
 - Gather the following credentials:
 - Federal Employer Identification Number (FEIN)
 - State Employer Identification Number (SEIN)
 - SIDES ID Number/Access Code
 - Add the email address ndol.uisides@nebraska.gov and ndol.uisidesev@nebraska.gov to your address book.
 - Notify your company's Information Technology Department to ensure that the email notifications are sent to your inbox instead of being blocked by spam filters.
- SIDES E-Response User Guide is located on the E-Response login screen.
- An email notification will be sent to the email address you provide at the time of registration when:

 - employee earnings verification information is required, or
 - an unemployment insurance eligibility determination is issued.
